

OFFICIAL RULES

Demand CS share your story campaign

Run date: June 7 – July 31, 2021

1. **ELIGIBILITY: NO PURCHASE OF ANY KIND NECESSARY TO PARTICIPATE.** Purchases will not increase chance of eligibility. “Demand CS share your story campaign” is open to U.S. legal residents, 18 years of age or older as of 6/7/21, who are licensed or certified pest management professionals who, in their course of work, apply professional pest management products for compensation, and who fill out the form on SyngentaPMP.com/DemandCS.
