

# 2026 Syngenta Partner Program (West)

## Rules and Regulations

REVISED JANUARY 12, 2026

### Program Period

**Program Period:** The 2026 Partner Program™ (West) begins on November 1, 2025, and ends on October 31, 2026 ("Program Period").

### Program Registration

**Pre-Registration:** Growers who registered for the Partner Program (West) in a prior year are automatically registered for the 2026 Partner Program (West). Registration shall remain effective for all subsequent years unless Syngenta receives written notification from the Grower stating that the Grower does not wish to participate in the Partner Program (West).

- Pre-registered growers who DO wish to change any or all of the information contained in their previous registration for the Partner Program (West) must submit a new Partner Program (West) Form ("Registration Form") with the revised information by the Registration Deadline.
- Pre-registered growers who DO NOT wish to change any information contained in their previous registration for the Partner Program (West) do not need to re-submit a new Registration Form.

**New Registration:** If not already registered, Growers may register for participation in the 2026 Partner Program (West) by completing and submitting an online Registration Form that is available at:

**Registration Deadline:** Registration Forms must be received by Syngenta by September 30, 2026 (the "Registration Deadline").

### Program Geography

**Provinces:** The 2026 Partner Program (West) only applies to Growers who are commercially active in the Provinces of: Alberta, Peace Region of British Columbia, Manitoba and/or Saskatchewan.

### Rules and Regulations

**Rules and Regulations:** The 2026 Partner Program (West) is expressly subject to the SYNGENTA GROWER PROGRAM RULES AND REGULATIONS ("Rules and Regulations") available at: [syngenta.ca/rules](http://syngenta.ca/rules). The Rules and Regulations are incorporated herein by reference and form an integral part of the 2026 Partner Program. Each Grower participating in the 2026 Partner Program (West) acknowledges having read and understood the Rules and Regulations.

### Program Rewards

**Reward Calculation:** The Program reward calculation is based on 2026 Suggested Grower Price (SGP) as stated by Syngenta. If there is no published SGP for a product, there will be a value assigned by Syngenta for the purposes of reward calculation. SGP and/or value are subject to change at any time. The reward calculation is based on meeting a minimum purchase of 320 minimum acres in at least two categories of the Portfolio Reward. The number of acres per unit of packaging are listed in Table 1.

#### PROGRAM REWARDS

**Portfolio Reward:** Growers who purchase 320 acres or more of products from each of the three categories will receive 8% off SGP (referred to as a Hat Trick). Growers who purchase 320 acres or more of products from only two categories will receive 5% off SGP (referred to as a Double-play). Only products in eligible categories will be paid.

**Category 2:** Axial®, Axial Maxx, Axial Xtreme, Axial Xtreme iPak™, Canvista®, Erebus™ Xtreme, Nelatic®, Sierra® 3.0 AG, Traxos®, Traxos Two, Traxos Xtreme, Traxos III, Reglone® Ion

**Category 3:** Miravis® Ace, Miravis® Bold, Miravis® Era, Miravis® Neo, Miravis® Star, Elatus®, Elatus® Era, Trivapro®.

**Crop Bonus:** To receive the Crop Bonus, Growers must purchase 320 acres or more of product from two to four of the categories within a particular crop. Cereals, Canola, Pulses and Soybeans rewards are based on purchases done within each crop. Only products in eligible categories will be paid.

The Crop Bonus opportunity is incremental to the rewards earned on the Portfolio Reward. Maximum rewards on the Crop Bonus are 9% with the exception of Products that are part of the Multi-crop Product Enabler whose maximum rewards are 7%.

Growers who purchase 320 acres or more of products from each of 2 categories within a crop will receive 4% off SGP;  
Growers who purchase 320 acres or more of products from each of 3 categories within a crop will receive 7% off SGP;  
Growers who purchase 320 acres or more of products from each of 4 categories within a crop will receive 9% off SGP;

Growers who purchase 320 acres or more of Reglone Ion + Miravis® Bold and/or Miravis® Star from the Canola Crop Bonus will receive an automatic 7% off SGP on both products.

Growers who purchase 320 acres or more from each of the Cereals Crop Bonus Category 2 and Talinor™ and/or Sabatis™ will receive 5% off SGP for their Talinor and Sabatis purchases.

**Multi-crop Product Enabler:** To receive the Multi-crop Product Enabler of 7% off SGP, Growers must purchase 320 acres or more of YieldON™, Reglone Ion, Megafol™, Cruiser 5FS or Miravis® Neo, which are listed in multiple crops. Multi-crop Product Enabler products earn a maximum of 7% on the Crop Bonus.

**Atuva Bonus:** Growers who qualify on the Pulse Crop Bonus and purchase Atuva™ PL and/or Atuva PL GR will earn rewards equal to that earned on the Pulse Crop Bonus on the Atuva PL brands purchased.
